#### THIRD INGRID-2 GENERAL ASSEMBLY MEETING TOOK PLACE 16-17 May 2019, HIVA-KU Leuven (Belgium)

During this meeting, all consortium members joined together at HIVA-KU Leuven to discuss the current state-of-affairs regarding the project. Bart Vanhercke (OSE) was invited to open the General Assembly with a presentation on the recent OSE publication 'Social policy in the EU: state of play and looking ahead' in which he addressed the changing narrative on the social dimension of the EU as well as some key issues on the social agenda. Later, updated information was provided regarding the project status, and specific attention was paid to work packages on dissemination, transnational access, and events. In addition, multiple interactive sessions were foreseen in which the consortium members presented research done in the framework of InGRID-2 and there was room for discussion considering relevant steps forward. The next General Assembly meeting will take place in June 2020.
